**EMERGENCY OVERVIEW**

**CAUTION**

**Section 4: FIRST AID MEASURES**

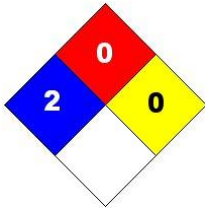
